



## One year in action: Annual monitoring report summary 2020-2021

Following one year of Hub activities, we are pleased to share [a four-page annual monitoring report summary](#) for 2020-2021. The summary captures the **key highlights** and **achievements per thematic area** of Hub supported work, including **examples from different country contexts**.

## End-to-end Hub support to UNHCR and WFP collaboration in Rwanda

The Hub has been supporting UNHCR, WFP and the government of Rwanda to ensure that the **most vulnerable refugees in camps are supported with basic humanitarian assistance**.

Facilitated by an in-country **Joint UNHCR-WFP Coordinator**, the Hub has supported a **joint post-distribution monitoring and needs assessment** of Burundian and DRC refugees ([Report/ Brief](#)), **comprehensive risk assessment and mitigation plan** and **community consultations** to validate the findings from the assessment, and to ensure community engagement in the targeting process. These activities supported finalization of **UNHCR-WFP joint targeting strategy for basic food assistance**, endorsed by the Government of Rwanda. The targeting strategy has been rolled out in refugee camps from May 2021, with targeted food assistance being implemented according to three vulnerability groups. You can [read a short brief on the targeting approach here](#). Currently, **appeals mechanisms** are being strengthened to ensure vulnerable refugees are not left behind.

[Lessons from the assessment](#) and community consultations have been captured, feeding into future Hub support, and guidance, learning and tools for future interventions. The Hub is now in the process of starting a **learning review on Hub support in Rwanda** to inform lessons on the targeting process, additional country support needs, and to inform global lessons on UNHCR-WFP collaboration on shifting from blanket to joint targeted assistance.

## UNHCR-WFP Joint Needs Assessment for Mantapala Settlement in Zambia



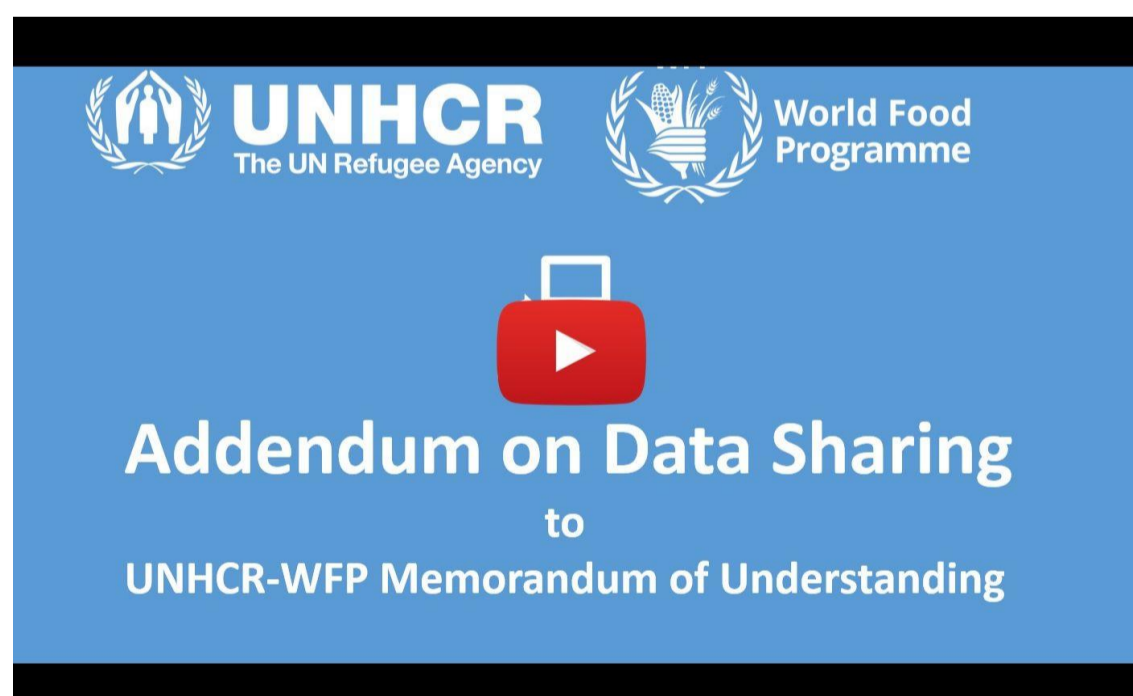
The Hub supported a UNHCR-WFP **Joint Needs Assessment for Mantapala Settlement in Zambia** to assess the levels of vulnerability and livelihoods resilience among refugee households, factoring the **impact of the COVID-19 pandemic**.

The findings reveal that **90 percent of refugee households in Mantapala settlement remain highly vulnerable**. The assessment **recommends the continued provision of food assistance** to all refugees in Mantapala and the **expansion and strengthening of livelihoods interventions to promote self-reliance**.
